1. **DISCLAIMER:** BY PURCHASING or ATTENDING and ENGAGING in A Cruise, Charter or Venture WITH PRIDECHARTERS.CA, PRIDECHARTERS.NET, HOLLAND CANADA LINE, ANY OPERATOR, Contractors, Sub Contractors and Individual Entities & Associations (direct or indirect) thereof – and hereon known as HCL; YOU (the purchaser, farer or attendee – INCLUDING YOUR GUESTS) understand (and conform) by the following without dispute.
2. Cruises are promoted by PrideCharters which is operated by Holland Canada Line Inc., Vancouver BC, (604) 970-1563, the Agent, hereon HCL. 2) Any other vessel is owned and/or operated by its respective entity and rendered fully Independent, including but not limited to: The m/v SOMEDAY Owned & Operated by Serv-west Charters Ltd, Vancouver. The m/v Sunset Bay II of Vancouver BC – hereon the OPERATORS. AND
3. **3) Any other establishment (bars, retail outlets, etc) as part of any promotion including its Holding Companies, Affiliations, Employees, Representatives, Associates and Officers – hereon the ESTABLISHMENTS – are Independent Entities and without any attachments, commitments, responsibilities or involvements with HCL or OPERATORS, whatsoever and have no Liabilities, Guarantees and Responsibilities whatsoever towards the promotion, charters, cruises and any venture hereof as promoted, conducted and executed by HCL. AND**
4. Ultimately You (not limited to You and Your Guests) shall hold HCL, OPERATOR and ESTABLISHMENTS harmless and indemnify them from any loss, damages and any liabilities or consequences thereof, for any time, whatsoever. AND
5. By attending or engaging in any Cruise or Charter you do so on the basis of “At Own Risk” and with full awareness of any risks that may occur.
6. **The consumption of alcohol on a vessel and on the water can be a dangerous and a lethal activity and is subject to provincial and/or federal law. Bringing your own alcohol onboard and consumption of alcohol is at your own risk and any repercussions or consequences thereof are your (and your guests) own full liability and responsibility, whatsoever.**
7. **YOU understand that partaking or sailing on the Zodiac or any vessel may cause physical discomfort or injury. You are fully responsible to report ANY PHYSICAL IMPAIRMENT or HANDICAP DURING TIME OF RESERVATION AND TO THE CREW OF ANY VESSEL WHILE BOARDING AND PRIOR TO DEPARTURE.**

8. The Rules:

- A. *The MASTER (Captain) of the Vessel HAS THE FINAL SAY AND HIS/HER DECISION IS WITHOUT DISPUTE OR ARGUMENT WHILE ONBOARD.*
- B. *You shall report any impairments (Physical/Mental) you may have or endure PRIOR to Departure.*
- C. *Smoking is permitted in designated areas.*
- D. *Littering overboard is a federal offense and harmful to the environment. DON'T LITTER.*
- E. *Throwing Cigarette Buts overboard is littering and is a FIRE HAZARD. (Buts can land on a lower deck)*
- F. *Jumping Overboard is NOT FUNNY and can be LETHAL – and is **not** permitted.*
- G. *Swimming of the Vessel is ONLY PERMITTED ONCE THE CREW HAS GIVEN THE OKAY AND THE VESSEL IS AT A FULL STOP AND ENGINES ARE OFF. **DO NOT ENGAGE IN SWIMMING IF THE ENGINES ARE RUNNING!***
- H. **PARKING** at the marina is absurd. Walk is 20-25min from the village, or a \$7 Cab Ride. A shuttle bus may be at the dock upon arrival at \$5/pp which will drop you off at Burrard/Davie area.
- I. Any reference to "FREE BBQ" or "FREE BEER" or "FREE BBQ & BEER" means that we give away the barbeque and beer. It DOES NOT MEAN that it is included in the price – it means we the operator are giving the aforementioned away by reasons not limited to excess inventory.
- J. BYOB permitted. BYOB = Bring Your Own Booze. You are our GUESTS! (Not Passengers!) Not all Vessels have liqueur license. Those vessels without a liquor license do not sell liquor.
- K. You must be of Legal Age and be able to provide legal identification to proof your age at any time while onboard.
- L. CASH GIVE AWAY is a Cash Back Promotion and does not constitute any gambling.
- M. REFUNDS. Tickets non refundable! If we cancel the charter - full refund, usually via company check or cash from the point of sale. Checks may take up-to 30 days to arrive.
- N. DEPARTURE TIMES ARE SHARP.**
- O. CRUISE ITINERARY up to the Captain and suggestions entertained. At the discretion of the Captain, the cruise may be limited in the False Creek area due to WEATHER CONSTRAINS.
